## 1 Timing

The Royal Academy of Fine Arts Antwerp organizes each academic year artistic entrance examinations for permission to enrol in the Bachelor of Arts in Visual Arts programme for the next academic year.

Per academic year, two artistic entrance examinations are organized, each spread over two calendar days.

- A first admission period is organized between 30 June and 15 July.
- A second admission period is organized between 22 August and 15 September.

Candidate-students from outside the EEA are strongly advised to take part in the artistic entrance examination organized in June-July. Candidate-students from outside the EEA must submit their application for a student visa as soon as possible after passing the artistic entrance exam. Only then can they obtain in time the visa required to follow the classes from the beginning of the academic year and can they gain the necessary access to the buildings and facilities of the Academy.

A candidate-student can only participate once in the academic year in the artistic entrance examination for a specific main subject and option within the Visual Arts programme.

## 2 Announcement

The dates and contents of the artistic entrance examination are announced by early March at the latest.

## 3 Administrative fee

To take part in the artistic entrance examination, candidate-students must pay a non-refundable administrative fee of 25 euro to be paid in advance online.

## 4 Registration and payment

Registration and payment for the entrance examination is possible online via the website <https://inschrijven.ap.be/Default.aspx>

## 5 Content

The artistic entrance examination may contain written, oral and practical elements (see <https://ap-arts.be/en/academy>). Examination content will vary by specific main subject and option with the Visual Arts programme.

## 6 Assessment

Artistic entrance examinations are assessed by a committee.

## **7 Composition of the committee**

Every committee is made up of at least one external expert and three members of the teaching staff of the associated main subject/choice option linked to the Royal Academy of Fine Arts. Members of the committee are prohibited from participating in the assessment of an artistic entrance examination of a spouse, a partner or a (blood) relative down to the fourth degree.

## **8 Report of the committee**

A report will be drawn up detailing the committee's activities, including the date, the decision taken and the motivation. This document is signed by the members of the committee, submitted to the student files administrator.

## **9 Proclamation**

On the second day of the artistic entrance examination, after the activities of the committee, a proclamation is made within the specialization with only the statement "passed" & "failed".

## **10 Publication of the committee's decision**

The decision taken by the committee will be communicated to the prospective student within 7 calendar days, counting from the day after the decision, via e-mail to the personal e-mail address given by the candidate-student.

Within a period of 7 calendar days, starting on the day after the publication of the decision, the candidate-student can request the School of Arts by registered letter to provide the motivation for the decision. The School of Arts sends the motivation to the candidate-student by registered letter or against receipt within a period of 7 calendar days, counting from the day after receipt of the request.

## **11 Enrolling as a student**

Candidate-students who have passed the entrance examination can only enrol in a Bachelor programme if they meet all general admission requirements and the language requirements as described in the currently applicable Education and Examination Regulations.

Candidate-students who have passed the entrance examination will receive an e-mail with all the information needed to enrol for the coming academic

With proof of passing the entrance test, the candidate-student may register only for the next academic year.
